- Session cookies: these cookies allow website operators to link the actions of a user during a
  browser session. A browser session starts when a user opens the browser window and finishes
  when they close the browser window. Session cookies are created temporarily. Once you close
  the browser, all session cookies are deleted.
- c) based on the purpose
- Technical cookies: these cookies are necessary to allow the user to browse the website and to benefit from its functionalities. If strictly necessary for the use of the website, these cookies do not require the user's prior consent and cannot be switched off. In this case, technical cookies

are also named "strictly necessary cookies". Instead, where technical cookies enable certain functionalities and services, enhancing the website, they are called "functional cookies".
